## d. Update on Teacher Incentive System

LWCS Teacher Incentive System 2011-12 spreadsheet provided. The original estimated payout was expected to be \$18,000. Most incentives were based on utilization rate. The target utilization rate for 2012-13 will be raised from 80% to 84%. No incentives were given on CAHSEE ELA or Math because no teachers met the 40% target.

#### e. LW Audit

The charter school had a loss of \$100,218 for 2011-12. Since LW is undergoing both charter renewal and WASC, it was important to have the auditor's opinion on the financial status of the school. Overall, the auditor

believes that the school is a strong and financially stable entity based on several factors including a positive net asset balance, a healthy current ratio, no outside borrowing and prior year positive balances.

Update: The loss in 2011-12 derived from a decrease in revenue. There was no ARRA EdJobs funding in 2011-12 (compared to \$64,000 in 2010-11). In addition, there was an increase in the Special Education encroachment for PUSD that reduced in-lieu of property tax revenue (by \$41,000 compared to 2010-11).

#### VI. Action Items

a. Revised LW Budget Approval (with approval of Proposition 30) Funding rates have been restored due to passage of Prop 30. Estimated Reserve is \$59,000. Question was raised whether depreciation will knock us into another deficit for 2012-13. Tomoko Patrick will contact the auditor.

Nicole Palmentiero asked whether a Health component could be added. Mikala Rahn responded that vocational health courses are not offered online.
